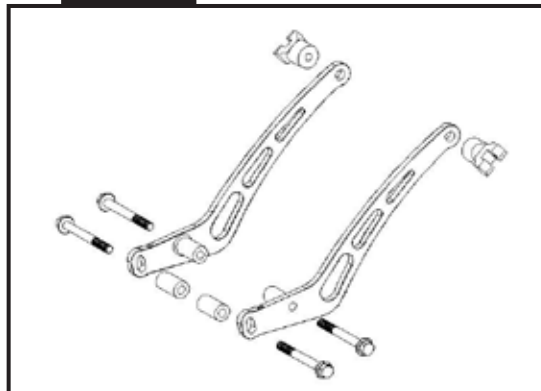

### PROCEDURE

- STEP 1** Remove the two bolts from under the left stock forward control mount while supporting the controls.
- STEP 2** Position the left cruise peg mount and one spacer (behind the slotted hole) to where the two stock bolts were removed.
- STEP 3** Replace the stock bolts with the longer ones supplied with the kit.
- STEP 4** With both bolts loose adjust the arm to the desired position by pivoting it on the front bolt. When in position tighten both bolts.
- STEP 5** Repeat this procedure on the right side.
- STEP 6** Install clevis and foot pegs and do any necessary final adjustments.
